Attention all Performing Artists:

### **Please confirm GIG with the venue before traveling!**

These guidelines are designed to be clear and upfront with our expectations and clarify what you can expect while here. We hope your experience with **Hookah Cafe** and your performance goes well! Please print and sign and leave with staff indicating you fully understand your obligation prior to performing. ***This is a requirement.*** If you do not agree with this document, then do not accept the gig via email. If you do agree...email us back with AGREED in the subject line. And of course, if there is a question – please don't hesitate to ask. Don't get caught short without a copy of your agreement on hand. This is a good habit!

- We require that you mail one (1) printed promotional flyer DIRECTLY to the venue at your own expense NO LATER THAN TWO (2) WEEKS prior to your show. Any additional promotional items sent (CD's, postcards, business cards, etc.) are solely the responsibility of the artist and CoffeeHouseTour.com and A. Warner Entertainment will not assume responsibility for, or refund the cost of any of these items. CHT and AWE expect all musicians to promote themselves as well as possible. We will not continue to support the musicians who do not make an effort on their own. In this case..more is always better.

**Show times and days are flexible and open. Let us know when you are coming through, or when you'd like to play, and we will accommodate. In general, the play hours are 9-12, but this venue stays open until 4 am. We need you ready to *start* playing at 9-11pm, so please time your set-up accordingly.**

**All cancellations must be made via email to the person that booked you as well as a phone call to the venue (910-762-1944) as soon as possible. Please put Gig Cancellation in the subject line. Your performance compensation is as follows: Free meal item and beverages, 100% tips and your merch sales.**

- Hookah Café is the former Folks Cafe and is a progressive, artistic and friendly music venue. The food is delicious! We encourage you to play your original music but also welcome a kitchen sink of styles including Reggae, Jazz, Bluegrass, Classical, Rock and Folk, rock.
- During the nice weather season, we are also open to outdoor playing in our "Parking lot café" as well.
- **Per CoffeeHouseTour's booking policy – though we do not like to use the term "censored" - please avoid the use of your loud and obnoxious catalog.** Poetry Artists and comedy routines are welcome!
- Bands are welcome. Please bring sound appropriate for a venue size of 50 people unless you are booked to play outside for a special event. We are going for quality of music, not excessive and useless volume. **A sound system is not provided by the venue, so you must bring your own sound. Please read venue specs here:**
